Outsourced Accounting System Optimization Cloud-Based Accounting During the COVID-19 pandemic, Manna Food Center, a food distribution and advocacy organization, experienced an influx of community need. Located in Montgomery County, Maryland, Manna's management team needed to develop new solutions and processes to meet this increased demand, and to manage accounting and budgeting tasks more efficiently. The Challenge

From 2020 to the end of 2023, Manna Food Center's assets grew from less than \$3 million to more than \$12 million. Due to the pandemic, an overwhelming number of community members experienced food insecurity and were in need of food distribution services and access to nutritious food. With a mission to end hunger in Montgomery County, Manna was committed to taking on the challenge.

However, the increased demand and rapid organizational growth left management scrambling to accommodate the volume and complexity of transactions. As they began to expand operations, Manna staff realized they needed new processes and internal control functions to eliminated manual reconciliation processes. In addition, the organization experienced turnover in its internal accounting department and needed assistance preparing for both the 2021 annual budget and audit.

Manna reached out to Cherry Bekaert's team in 2020 for budget and audit assistance, and the partnership expanded to encompass outsourced accounting.
